PERMITTEE INSURANCE REQUIREMENTS FOR USE OF DISTRICT FACILITIES

- I. **Acceptable Evidence of Appropriate Insurance Coverages:**
 - A. Permittee shall submit to the District a Certificate of Liability Insurance naming the District as the Certificate Holder.
 - B. An Additional Insured Endorsement is required with the District's name and address on it.

- II. **Minimum Coverages:**
 - A. General Liability – Occurrence Basis Required and Additional Insured
 - B. Host Liquor Liability (if alcoholic beverages will be served at the event at no charge), or
 - C. Liquor Legal Liability (if alcoholic beverages will be sold at the event).

- III. **Minimum Limits:** The Minimum coverage limits shall be in the principle amount of \$1,000,000. Combined Single Limits as to bodily injury to persons and damage to property, with a \$2,000,000 aggregate.

NOTE: A Certificate of Insurance must be received by the District prior to the District's approval of the Use of Facilities Permit.
