**RULES:** Pitching Arc-16 foot S.C.M.A.F. **FIELD CONDITIONS (after 3:30 p.m.) (805) 584-4413, 4#**

1. No alcoholic beverages permitted at ball fields at any time. Any player suspected of being under the influence of alcohol is subject to ejection and suspension. Ejection can be based solely at the discretion of the umpire.
2. Home team is listed second. Teams may play with 8 players.
3. Awards: League Champion 1<sup>st</sup> Place team and 16 individual awards. Top 4 teams make play-offs based on overall ranking. 1st tie breaker is head to head, 2nd tie breaker is run differential between teams.
4. **Each player must be able to show positive I.D. at every game.** If your team plays with any illegal players, it will be an automatic forfeit. Game time is forfeit time.
5. Game time is 1 hour 10 minutes. 15 run rule after 5 complete innings (4 ½ if home team is ahead).
6. Rules and conditions of league play shall follow the R.S.R.P.D. league rules and 2011 S.C.M.A.F. softball rules.
7. Use of illegal bats is not tolerated. If any bat found on "Oak Park illegal bat list" is used, player will be automatically out.
8. Any player ejected from a game will serve a suspension the next game, NO EXCEPTIONS. Team manager is subject to a 2 game suspension if ejected.
9. League director must be notified of any forfeits within 24 hours of game time. Failure to do so will result in a forfeit fee of \$30. Forfeit fee will be due to the league director within 72 hours of the forfeit. Failure to do so will result in an automatic forfeit of the team's next scheduled game. Each game thereafter will be forfeited until the fee is paid.
10. A complete roster is due before the first pitch of the first game. Players may be added to the roster until the first pitch of the team's 3rd scheduled game. After the 3rd game, all rosters are final.
