- LEAGUE FEE:** ***\$520.00 – NO CASH WILL BE ACCEPTED. Check, Money Order, or Credit Card will be accepted.*** Checks returned for any reason will be charged a \$20 NSF fee, and teams will be removed from league. **FEES ARE REQUIRED AT TIME OF REGISTRATION - NO EXCEPTIONS!**
- SEASON:** Games will begin Monday, February 27, 2012 and last approximately 12 weeks.
- ROSTER:** Each roster is limited to 16, including the manager. Properly completed rosters will be due WITH REGISTRATION – **NO EXCEPTIONS!** NO REGISTRATIONS WILL BE ACCEPTED WITHOUT FEES.
