RULES

1. Home team listed second. Home team will wear gold, visitor white.
2. Every player must play two full uninterrupted periods.
3. No full court pressing, except last four minutes of game if deficit is 12 points or less.
4. When a team is ahead by 20 or more points, they must play defense inside the 3 point line. Once offensive team penetrates 3 point line, the defense may leave 3 point area to defend.
5. Games are four (7) minute running periods and one (8) minute period. Stop clock in last two minutes of 5th period only if lead is 12 points or less.
