RULES

1. Home team listed second. Home team will wear gold, visitor white.
2. Every player must play two full uninterrupted periods.
3. Teams may full court press.
4. When a team is ahead by 20 or more points, they must play defense inside the 3 point line. Once offensive team penetrates 3 point line, the defense may leave 3 point area to defend.
5. Games are four 7 minute running periods and one 8 minute period. Stop clock in last two minutes of 5th period only if lead is 12 points or less.
